APPLICATION

To: Commonwealth

I make this application for the:

- 1) Restoration and curing of divine rights of mothers and fathers, grandmothers and grandfathers of good standing, to actively participate in fathering and mothering their children on just and equitable terms at all levels of lawful jurisdiction being the sea, land and air, should a separation have occurred between mothers and fathers and/or their respective sons and daughters;
- 2) Restoration and curing of the Crown and all statutory bodies across the Commonwealth in accordance with the Commonwealth of Australia Constitution Act 1900 (UK) (Constitution);

- 3) Restoration and curing of all Parliaments and Government officers and apparatus across the Commonwealth in accordance with the Commonwealth of Australia Constitution Act 1900 (UK), and a public record of oaths of office and allegiance by each lawful officer or public representative of any public office, is maintained daily through an online public gazette;
- 4) Restoration and curing of the judicial and legal system across the Commonwealth in accordance with the Commonwealth of Australia Constitution Act 1900 (UK) whereby all private oaths of allegiance are outlawed and lawful jurisdiction and competency of the court is declared across all Commonwealth courts of law prior to anybody asked to 'all rise';
- 5) Restoration and curing and reuniting of the physical loving bonds between me and my son XXXXXX through an equitable shared co-mothering and co-fathering structures with his mother XXXXX XXXXXX of the XXXXXXXXX Family a.k.a. XXXXX XXXXX XXXXXXXX *ens legis* (XXXXX);
- 6) Remedy, curing and redress for all unlawful behavior and practices of our authorities across the Family Law and Family Violence System applied against me and all other people throughout the Commonwealth whereby reparations against unlawful and legal mal-practice institutes expedient healing and remedy at law and restores the good faith of the people in the Commonwealth Judicial system and protect the common good and common-weal of the families that underpin the heart and soul of our great nation in togetherness or in separation/divorce;
- 7) Remedy unlawful practices applied against me and the companies / trusts of which I serve as Director in accordance with applicable penalties where compensations and remunerations sought are disbursed in accordance with my preferences as set out in my Orders;
- 8) Revoke, remove, extinguish, nullify any police records, warrants, penalties, infringements, all debts of whatever form against me or the businesses/trusts for which I act as a Director or have an shareholding interest across the Commonwealth;
- 9) Restoration of obeisance for all lawful instruments of remuneration and remediation including Bills of Exchange struck through proper procedure and anchored in lawful jurisdiction in accordance with the Commonwealth of Australia Constitution Act 1900 (UK);
- 10) Reimburse me for all claims I hold against the Commonwealth, and for my professional time lost - calculated at \$XXX/hour - in dealing with all authorities and their unlawful behavior across the Commonwealth as a consequence of being unlawfully obstructed from fathering my son X...X;
- 11) Restoration of all healing modalities at law whereby any modality represented by an industry body/association of at least 50 practitioners qualifies the such modality to exist as lawful medicine.
